

# Important Health Notice

## Immunization Requirement for the 2020-2021 School Year

**All in-coming 7<sup>th</sup> grade students for 2020-2021 are required to have booster immunizations of tetanus, diphtheria and pertussis (Tdap) or tetanus and diphtheria (Td) and Meningococcal, (MCV4) (serogroup A, C, W, and Y).**

The Ohio Department of Health (ODH) has additional immunization requirements for school entry for all of Ohio's in-coming **7<sup>th</sup> grade students**. The Tdap requirement has been in effect since the 2010-2011 school year. Beginning with the 2016-2017 school year, ODH required parents of children entering the 7<sup>th</sup> grade to have their preteen vaccinated with the **Meningococcal (MCV4)** vaccine as well as the **Tdap** booster.

**Written verification** from your child's health care provider, indicating the complete date (month/date/year) and type of vaccine (Tdap/Td and MCV4) that your child received, is required to be turned into the school health staff by June 2, 2020 for the 2020-2021 school year. If your child has already been vaccinated with the additional requirements of **Tdap/Td and MCV4**, please forward written documentation from your health care provider to Ms. Rawn, RN, School Nurse, as soon as possible. If your child has not yet been vaccinated with the tetanus, diphtheria and pertussis booster or the meningococcal vaccine, please be certain your child receives these vaccines and provide the school with written verification from your health care provider of the date/s received and type of vaccine that was administered. This documentation is **due Tuesday, June 2, 2020, for the academic school year 2020-2021**. Refer to your child's health care provider for any additional questions.
